

SGA International ACWI ex-U.S. Equity

Global stocks again delivered negative returns in the third quarter, with investors taking risk off the table, as tighter financial conditions, persistently high inflation, and concerns of an economic slowdown weighed on market sentiment. In this environment, the MSCI ACWI ex USA Net Index returned -9.91% and the International ACWI ex-U.S. Equity strategy outperformed the benchmark.

The SGA Alpha Model had modestly positive performance for the quarter among non-U.S. large cap equities. Within the Model, outperformance was driven by contributions from the Growth, Sentiment, and Quality categories. Notably, the Growth category rebounded after significantly underperforming during the first half of the year. The Valuation category detracted during the quarter after being the top contributor in the first half of the year.

Stock selection was positive in Communication Services and Industrials, which was partially offset by weak selection in Financials and Information Technology. In Communication Services, positive selection was driven by PT Telkom which has benefitted from rapid mobile data growth in Indonesia. In Industrials, Wolters Kluwer was a relative top performer as it continued to report strong results. Weaker selection in Financials was driven by New China Life Insurance and China Life Insurance which were both impacted by weaker growth in the Chinese life insurance market. In Information Technology, Realtek Semiconductor and LG Innotek were both detractors as concerns about lower consumer spending weighed on their outlooks.

Stock selection was positive in China and Japan and was partially offset by weak selection in Brazil, South Korea, and Australia. Positive stock selection in China was driven by exposure to higher quality firms such as CSPC Pharmaceutical which outperformed low quality firms that have larger benchmark weights such as Wuxi Biologics and BYD Company. In Japan, Daito Trust Construction benefitted from strong order growth along with higher prices. In Brazil, JBS SA declined after an industry publication reported a slowdown in Chinese cattle imports. In South Korea, previously mentioned LG Innotek was the main detractor while in Australia, the base metal producer South32 underperformed as aluminum and copper prices fell during the quarter.

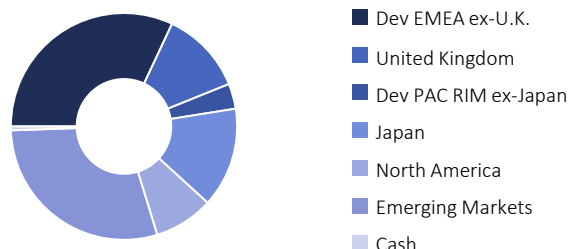

The minimum account size for this composite is \$100 thousand. Please note that the maximum annual management fee for the respective period may differ from the actual investment advisory fees incurred by clients.

The annual composite dispersion presented is a gross of fees asset weighted standard deviation calculated for the accounts in the composite the entire year and is only presented for periods with more than five accounts in for the entire year. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request.

Beginning July 1, 2019, the composite policy requires the temporary removal of any portfolio due to a client-initiated significant cash inflow or outflow, excluding securities received or delivered in kind when the cash inflow or outflow represented 10% or greater of the portfolio assets.
